Canonical Requirements Regarding Godparents (Sponsors)

According to the *Code of Canon Law*, only one Godparent is required. If there are to be two Godparents, one must be a male and the other must be a female. Additionally, the following requirements must be met:

1. At least 16 years of age;
2. Have received the three Sacraments of Initiation: Baptism, Confirmation and Holy Eucharist;
3. Be a registered member of a Catholic parish, who regularly practice his/her faith;
4. Canonically free to carry out the office of Godparent.

Note: Godparents not from St. Cecilia Catholic Church, must provide a Letter from their Pastor that testifies to the requirements stated above.

Canonical Requirements Regarding Christian Witnesses

According to the *Code of Canon Law*, a validly baptized person who is a member of another Christian community can be admitted as a "Christian witness" if there is at least one Roman Catholic Godparent of the opposite sex. Additionally, the following requirements must be met:

1. At least 16 years of age;
2. Be a non-Catholic who is validly baptized and practices their faith in Christ in a sincere and visible way;
3. Not a Catholic who has formally left the Catholic Church, even if they are now active in another Christian community.

Note: The Christian Witness must also procure a letter from the minister of his/her Christian congregation attesting to their baptism and their continued practice of the Christian Faith.
